## Committee Reports:

Public Health: Kim Schultz advised the Northeast Nebraska PHD submitted an application to FEMA for reimbursement assistance for the payment and installation of a safe room after the 2013 Wayne tornado which has been approved. Deb Scholten has retired as the Northeast Nebraska PHD as of 9/30/16 and Julie Rother is now the Public Health Director for that district. A 191 class will be held Dec. 2<sup>nd</sup> at the Dakota County Public Health.

Nic Kemnitz passed out information from the TEPW in Lincoln. Our region has a new planner Leo Larkin and some of the re-write schedules of our LEOPs have been changed. Mark DeKraai advised he felt the TEPW and THIRA went well. The latest NRIN maps were passed around.

The FY17 grant needs to have requests set by the December meeting so we're ready when they need it. Requests named at the meeting were Salamander support, NRIN fees, 25% to law enforcement and the 2 towers that need to be constructed for NRIN (Dixon and Knox)

Kevin Garvin attended the APCO-NENA Conference and advised it was good. There is a new bill putting 911 in the hands of the Public Service Commission. Col.Sankey advised at this time there is no number of PSAPS set that will be operational. (Consolidation of PSAPS) If your 911 coordinator or sheriff gets any letters from Mission Critical Partners they must not ignore them.

There was a request from NRIN asking for funding for NRIN promo material. After much discussion Deanna Beckman made a motion with reservation to move forward to support funding of NRIN promo materials, seconded by Trent Howard. RCV
