# Southeast Nebraska Emergency Management Group Regional Governance Board MINUTES – Regular Meeting February 1, 2018 Gage County EOC, Beatrice, Nebraska

### Call to Order

Vice-Chairman Brian Kirkendall called the regular meeting of the Southeast Regional Emergency Management Governance Board to order at 10:02 a.m. on February 1, 2018 at the Gage County EOC, Beatrice, NE. Vice-Chairman Kirkendall noted that the meeting was being held in compliance with the Nebraska Open Meetings Act and a copy of the Act was available for inspection in the meeting room.

# Funding Requests & Claims – equipment request for Printers – Lancaster County

Motion was made by Jefferson/Saline, seconded by Nemaha to approve the funding request from Lancaster County to purchase two id printers, one for Pawnee County and one for Thayer County as previously agreed upon in past meetings in the amount of \$20,000.00 out of the FY2017 grant. Voting aye were Lancaster, Seward/York, Fillmore, Otoe, Richardson, Thayer, Cass, Gage, Jefferson/Saline, Johnson/Pawnee and Nemaha; voting nay were none. Motion passed.

### Funding Requests & Claims – NRD Tower Lease for NRIN system in Burchard – Johnson/Pawnee Counties

Motion was made by Fillmore, seconded by Gage to approve the funding request from Pawnee County to pay a lease in lieu of rent for electricity for NRIN project on the water tower in Burchard in the amount of \$600.00 with the grant year to be determined later. Voting aye were Nemaha, Jefferson/Saline, Gage, Cass, Thayer, Richardson, Otoe, Fillmore, Seward/York, Lancaster; voting nay were none; Johnson/Pawnee abstained. Motion passed.

### **Proposed Projects for workplans – Executive Board**

James Davidsaver informed the board of some changes being made to some Subject Matter Expert groups as follows: Ty Windle replaced Mark Hosking on the PET group, Capt. John Vik Lancaster County Sheriff's Office replaced Don Gross on the Law Enforcement group, Roseann Dobesh-DeGraff replaced Sandy Weyers on the Citizen Corps group. Davidsaver also explained to the group that the IJ is now requiring a regional appointee to the Senior Advisory Council and James Davidsaver has volunteered to be on the SAC this year.
