- a) Financials: Jim reported on the grants. 2015 deadline is Aug. 2018. A request has been made by Brandon Myers to use grant funds for CERT train the trainer expenses in Emmitsburg, MD.

- **b)** Use of the laptops and lpads: Jim made a motion to create a procedure for reissue of the equipment returned by Imperial P.D. Interested agencies should make a request in writing to the chair, Duane Dreiling. Duane will review/approve requests and Jim will handle the paperwork. Char seconded. All were in favor.

## a) Discussion of training for CERT and Train the Trainer for ICS 300-ICS 400

Char moved and Alan seconded a motion for SWPETR to use of homeland security grant funds for cert training and for 300/400. All were in favor. Motion carried.

**b) Vote for a board member for NRIN** Char moved, seconded by Roger nominate Roger to be the southwest region's representative on the NRIN board.

### 6) Good of the Group:

Kate talked with the group about law enforcement projects around the state and subject matter experts. 20 projects across the subject areas will be reviewed. There was a great THIRA 3 years ago, but it will not carry us into the future. Kate will be glad to help with this process. If the region does not follow through on the process, the state THIRA will be used, with state priorities.

Heidi reported that the health care coalition has been reactivated. She will need an emergency manager willing to participate, and is hoping Brandon will resume participation. Anyone else who is interested in participating should contact Heidi.

Larry Fichtner from NEMA reported on activity. Fire school coming up- NEMA tracks personnel through the sessions. There is an IS-402 class in Sidney next week and a Logistics Chief class coming up in the panhandle. Wayne will be hosting a G557 course with rapid needs assessment and information on new FEMA planning guidelines.

Logan reported NEMA is looking at a new program called "Bold Planning," which may be purchased for the state. They are planning a webinar toward the end of April to see the program and discuss.
