Mr. James Lundsted, Region VII Coordinator for the States of Iowa, Kansas, Missouri and Nebraska, Office of Emergency Communications (OEC) was introduced by Chair Steve Oltmans. Mr. Lundsted then gave a brief overview of his role.

Mr. Lundsted works on behalf of FEMA Region VII and the Department of Homeland Security to provide technical assistance to local and state programs. This assistance is part of the National Emergency Communications Plan, Goal 2 – 75% of all counties and municipalities must be able to demonstrate response-level communications involving multi-jurisdiction and multi-disciplinary response within one-hour of an incident. A supplementary priority for the Office of Emergency Communications is the convergence of voice and data, and the integration of broadband in public safety communications. OEC is offering a tool, NIXEL, to assist public safety entities release OEC approved messages via twitter. Mr. Lundsted stressed the importance of including technology use in plans, exercises and training, noting his office is available to provide technical assistance if requested.

2. Review & approval of meeting notes from the previous meeting
Paul Johnson made a motion to approve the Dec. 10, 2010 minutes with the suggested changes. Bill
Bowes seconded the motion; the motion passed by consensus.

### <u>Discussion Items</u>

#### **Updates and Reports**

- 1. Tri-County/UASI management & Administration update
  - a. MSA vetting process phase II Phil Ruhe & Steve Oltmans

The MSA vetting process for this area will initially be based on 2009 census estimates. The MSA score determines the position and status of the Tri-county UASI for the 2011 FY. Tri-county UASI

Members were encouraged to contact the Congressional delegation, specifically Senator Nelson who serves on the Homeland Security Committee, to advocate for continued inclusion of the Tri-County area in the Urban Area Security Initiative (UASI) program.

b. Tri-County Charter- Gail Braun

In addition to the MOU and By-Laws submitted for the Tri-County UASI, the federal government requires a charter for the Tri-County UASI be submitted. Michelle Peters, city attorney with Omaha, has reviewed the charter guidelines and is willing to work with the Mayor's office to create the requested document. Mark Desler made a motion to authorize Michelle Peters to draft a charter for review by the Mayor. Kevin Pokorny seconded the motion; the motion passed by consensus. NEMA provided input to tie objectives and goals together for the Tri-County Charter; Lynn Marshall will review the Charter and suggested changes by Jan. 21, 2011.

c. FEMA monitoring visit with Corey Walz – Gail Braun

Corey Walz will visit at the beginning of September and will complete one-on-one interviews of stakeholders and committee chairs.

2. Financial update & report – Scott Crites, City of Omaha Finance Department

Final filing is complete for 2007 funding. Project spending is moving through 2008 funding; \$377,000 remains with encumbrances. All 2008 Funding must be spent by Aug. 31, 2011. Spending has now begun for 2009 funding. The Omaha City Council is reviewing the 911 Communications project.

- 3. Standing committee reports
  - a. Emergency Management: Bill Pook, Region 5/6 Emergency Management
    The PET Committee will meet every other month on the first Mondays, 1:00 3:00 PM, at
    Bellevue Fire Training Center, beginning January 2011. The Tri-County Target Capabilities
    Assessment is complete and results are available online under a secure server. These results will help committees identify gaps and needs for future programs. Members should review the results.
  - b. Communications: Mark Conrey, Douglas County 911 Communications

The communications committee met regarding the implementation of the communications upgrade project, which should be complete in Sept. 2011. The communications work plan was submitted, but some additions regarding sustainability and GIS are expected. The committee will also review the communications response to the Millard School shooting and evaluate the lessons learned. Mark Conrey met with NEMA regarding the Mutual Aid Plan, which should improve continuity between the Region and the Nebraska State Patrol.

- c. Critical Infrastructure/Key Resources: Pete Neddo, MUD
  - Safeguard Iowa will present at the February 2011 committee meeting.
- d. Urban Law Enforcement: Lt. Mark Desler, OPD

The Law Enforcement Committee is on track to spend 2008 and 2009 funding. At the next committee meeting, Lt. Desler will present spending requests for robots and technological equipment for future purchase.

e. Rural Law Enforcement: Captain Kevin Pokorny, LaVista PD

The Law Enforcement Committee will be planning future training opportunities, which will likely focus on peer training and training for patrol officers.

f. Urban Fire: Scott Baughman, OFD

A NEMA-approved ring detector technology training course will be held March 21, 2011.

g. Rural Fire: Chief Bill Bowes, Papillion FD

The next Rural Fire Committee meeting will be held in February 2011.

h. UASI COOP Subcommittee: Steve Oltmans

Denise Bulling, PPC, met with Steve Oltmans and the Emergency Managers to review the planning report. The planning report was revised to address prior concerns regarding verbiage. The recommendations from the report are to 1) complete COOP Planning and 2) complete a work plan to increase capacity within the departments. FDI Consulting presented a revised scope of work to include key county departments and key Omaha city departments. Funds already sent back to the Nebraska Emergency Management Agency via MOU would be used to pay for the work of FDI Consulting. Dave Fulton of FDI Consulting assured working group members that his initial survey tool will be customized to reflect the language and needs of city/county governmental departments. Additional suggestions related to use of FDI or customization of the proposed process can be sent to Phil Ruhe or Gail Braun.

- 4. Reports from other associated Homeland Security Federal Grant Programs
  - a. Omaha Metropolitan Medical Response System (MMRS) Phyllis Dutton

The 2007 budget is complete, and 2008 budget is near complete. The ASPR Grant and respective work plan were submitted to the state. OMMRS will hold training with the biocontainment unit on March 11 for 22 hospitals. A training session for hospital public information officers and behavioral health personnel will be held April 1, 2011. A disaster preparedness program for journalists and journalism students will be held April 2, 2011.

- Buffer Zone Protection Programs (BZPP) Mark Desler
   It is anticipated that existing buffer zones will receive increased funding in the coming year, and that new buffer zones will be established. FY10 spending plan for the area BZPP is pending approval.
- c. Citizen Corps Program Phil Ruhe for Sgt. Erin Dumont, OPD Upcoming events include the Omaha Police Department Salute to Safety on May 7, 2011 at Westroads Mall and Severe Weather Awareness week on March 22 – 26, 2011. The Citizen Corps will be preparing PSAs and outreach materials. The next meeting will be held Jan. 24, 2011 to discuss infrastructure for the Tri-County volunteer corps.
- 5. Update on Planning Project –Public Policy Center, Denise Bulling No additional discussion.
