1. Tri-County SHSG Management & Administration Update – Phil Ruhe
 - a. FY 2014 SHSG: The FY 2014 SHSG is ending on August 31, 2016. The PET Sub-Committee will discuss the PET project balance of approximately \$31,360.19 after this meeting.
 - b. FY 2016 SHSG: NEMA conducted the FY 2016 SHSG IJ Workshop and Senior Advisory Committee (SAC) meeting on April 14; thank you to all that attended. The Tri-County PET Region requested funding in the amount of \$836,850 and agreed to cuts of \$124,000, resulting in an anticipated allocation of approximately \$712,850. However, as noted in my April 25 email, there was an error with how available funds were calculated, resulting in the need to cut an additional \$746,900 statewide. NEMA will re-convene the SAC to discuss these cuts in the coming weeks.
